To the Honorable Board Members of the Ohio Commission on Hispanic/Latino Affairs

The highlight for these two months focused on the completion of the 2015 Latino Education Summit at the University of Akron. The summit brought together approximately 300 participants and there were 13 best practices presented through a series of workshops and conferences throughout the day. Additionally, we were able to present Dr. Luis Proenza with "La Cumbre" Award (The Summit Award) to recognize his work towards Education and the University of Akron. Additionally, this year's summit had a group of about 50 high school students who participated with a specially designed track for them. National keynote speaker Dr. Victor Saenz presented on access to higher education and the case for diversity and inclusion. As in years past, the summit was co-chaired by Senators Charleta Tavares and Peggy Lehner. Additionally, five state representatives from the region confirmed attendance to the event along with the Associate Superintendent for the Ohio Department of Education, Jennifer Felker.

In March, we worked to finalize preparations for the six Minority Health Month Workshops. This project required intense coordination as each event involved selecting and coordinating with a local partner, securing speakers for the different subjects to be covered, and coordinating the marketing of the events at the local level. Additionally, our team has been working in collaboration with Amanecer to host the Latina Women's Conference. This event will provide leadership development sessions in the morning, including Personal Image, Social Services Resources, How to turn a hobby into a business, Legal Resources, Work, Family Balance & Time Management, Health & Nutrition Balance, and Resources for Children with Disabilities. It is expected this women's conference will bring 200-250 women.

We continue to make progress with our Language Access Project. Natasha Curtis has started gathering data from different regions of the state regarding language access and interpreting



services in health care. A survey has been sent to contacts at different hospital systems, and to individuals who are the point of contact for Latinos seeking health care services. We will be able to provide a full report on this project before June, 2015.

On February 19th, Director Cavanaugh presented testimony (see attached) for the FY 16-17 Biennial Budget at the House of Representatives Finance Subcommittee on Primary and Secondary Education. We will be tracking the budget process and will keep you informed on the progress of our biennial budget as it is considered. Additionally, we continue work with the Bureau of Workers Compensation, the Ohio Secretary of State's Office and the Department of Administrative Services, Equal Opportunity Division (MBE and EDGE Programs) on specific outreach programs for the Latino community.

Director Cavanaugh attended the United States Hispanic Leadership Conference in Chicago and participated in the conversations for the Student Leadership Series. We hope to be able to work more closely with USHLI to bring an increased number of student leadership development and civic engagement opportunities to Ohio in 2015 and 2016.

Finally, we are delighted to welcome Andrea Magaña Lewis as our new Public Policy Officer, effective March 23rd, 2015.

Regular e-campaign notifications are being sent to our stakeholders.

Grants Management and Implementation—

Steady progress is being made for grants MHM 05-15 and MGS 03-15. The first grant focuses on Minority Health Month, while the second grant concentrates on language access and cultural competence. When appropriate, the plan is to conduct the educational/training portion of this grant parallel to the minority health month event as we will be targeting the same audience

The main activity for these two months has been the six workshops to be implemented in March and April. The responsibilities include building partnership with local host organizations, working with them to develop the list of speakers, securing the speakers, promoting the event through the local networks and making sure to handle all logistical matters regarding the events. Overall, we will be working with at least 7 Latino serving organizations who will act as our partners in

The first workshop of the series was successfully held in Dayton on March 28, 2015. Our local partner, the Hispanic Catholic Ministry did a great job working with us to not only deliver an excellent program, but also distributing valuable educational information prior to the event so the wider community would benefit. The Dayton workshop attracted 30 participants.

This project is presenting the opportunity for the commission to work with seven different Latino serving organizations who are our partners in six major cities across Ohio. We hope this program will help to strengthen local health education projects and increase understanding for the Hispanic community on how to best utilize health services, understand the use of language access and increase the use of health practices that will improve their overall health.
